Health Guarantee Purchase Agreement Contract

***Failure to pick up your puppy or have puppy shipped by the pickup date or failure to have your puppy paid by 8 weeks of age will mean forfeiture of all payments and any rights the Buyer had to adopt the puppy in this contract or any other puppies. We reserve the right to cancel the sale of any puppy at any time up until the time of transfer of the puppy for any reason we feel is appropriate. Seller and Buyer agree that the above described puppy is a Bernedoodle.

Deposits/Payments/Refunds: Payments made with PayPal cannot be disputed for any type of payment reversal. All Money/payments placed on a puppy are NON-REFUNDABLE. No puppy is considered reserved until purchase agreement is received and signed along with a non-refundable deposit. Upon receipt of your deposit, the puppy that you have chosen will be taken off the market and will be held for you. Seller accepts Cash, Cashier's Check, Money Order, Wire Transfer, Chase Quick Pay, Zelle Quick Pay, Credit Card or PayPal using the send money to friends and family option. All electronic payments will be charged a 6% MI sales tax. Deposits will be taken on a first come, first serve basis. To reserve a puppy, an initial deposit of \$500 is required. There shall be NO REFUNDS of the deposit once your puppy is picked. If the puppy that you are looking for is not born your deposit may transfer it to another litter. You may however transfer to another litter one time only! Failure of the Buyer to complete this purchase would subject Seller to lost opportunities to sell the puppy to some other Buyer

and retention of the deposit or any other payments is meant to compensate Seller for loss of other opportunities to find a suitable home, loss of income and extra expenses. This deposit signifies the intent on the part of the Buyer to follow through with the purchase of this puppy. ALL PUPPIES PURCHASED WITH FINANCING CANNOT GET A REFUND AS WELL only a exchange or assistance with rehome but dog stays in buyer's possession because dog was paid by third party company.

Communication: If at any time you have an issue or miscommunication please never hesitate to contact us. Our goal is to connect you with a puppy that can be part of your family for years to come. We only approve families that have demonstrated to us that they are ready for a long-term commitment and with this we take a very personal approach to assisting each buyer in choosing the perfect puppy to meet their needs. Lack of communication on the buyers part can result in the loss of purchasing a puppy and no refund will be issued. Examples include, not responding back to me but checking messages, not agreeing to meet or changing plans, not making payments if a plan was put in order.

Transport/Shipping: We offer flight nanny services in person at your local airport. Prices range from \$500 - \$900 in the USA (subject to change based on airfare and destination). We do NOT ship cargo. Payment Schedule: Full balance is due and payment must be cleared one week prior to delivery. Once payment is fully cleared, we will hand deliver to you or you may pick the puppy up. If you are picking up the puppy in person payment will be due upon pick up. We offer ground transportation as well at a extra fee of \$100/hour up to 5 hours anything after that we can use our transportation company. However the cheapest way is the fly in yourself and I meet you at your local airport. If Buyer for any reason cannot complete the transaction by the time the puppy is ready to leave; the Buyer defaults and understands the reserved puppy will be offered to the next available person on our waiting list with no refunds given.

Health Guarantee: The Seller guarantees this puppy to be of sound health and temperament at the time of the sale. The Seller will provide a health record of all shots, worming, and a veterinarian exam. The Buyer agrees to take this puppy to a licensed veterinarian of their choice within 72 business hours. Failure to have the puppy examined by a vet within three days of the puppy's delivered/picked up date or if the Buyer fails to provide required immunizations and medical treatment will void this health guarantee. Dehydration, Diarrhea, Hypoglycemia, Hyperglycemia, Coccidia, Kennel Cough, Internal and External Parasites, Giardia, Fungal Infections, parvo, distemper, adenovirus (more then a week later) or any condition that can be corrected by veterinarian treatment and any other preventable conditions are not covered. To prevent these please follow my instructions on not taking your puppy out other then your yard or around other dogs until the rest of their vaccinations have been given. We provide a one (1) year health guarantee for life-threatening health issues (valid until the puppy's FIRST birthday). Illnesses must be documented in writing by a licensed vet within 72 business hours and be proven to be genetic (not a assumption). Umbilical hernias can happen when the mom chews the umbilical cord too hard and causes trauma, it may also be genetic but the cause is unknown. In the event your puppy has this I will inform you but this can be fixed at the same time your puppy gets spayed/neutered and is not life threatening or serious. If the puppy will be used for breeding the seller agrees to pay the difference it will cost to get fixed with the simple surgery. We do not test hips, eyes or patellas as there have too many environmental factors that affect the readings there for they are not covered. The Seller must be informed of the examination that indicates that at the time of sale, such animal was unfit for purchase due to life threatening illness, disease, or genetic defect with proper documentation by a licensed vet. I will then meet the buyers with the puppy at my veterinary office for a second opinion. If the puppy was in fact unfit for purchase Buyer may return the puppy for an exchange

of equal value and the failure to do so within 72 hours will result in the cancellation of a replacement puppy. The seller will offer a replacement puppy of comparable value and no money will be refunded. This is subject to availability, breeder's first choice for breeding program then the buyer second. Conditions not considered life threatening and therefore not covered include but not limited to luxating patella,, collapsed trachea, etc. If the condition can be treated, it is NOT considered life threatening. In the event of a life-threatening condition the affected puppy must be returned with all veterinary documentation at the Buyer's expense. The Buyer understands that a replacement puppy will only be given if it's discovered to be a hereditary problem and not due to accident or illness. The Seller guarantees the puppy against fatal viruses for 72 hours. These include Distemper, Parvo, and Corona. It does not include Coccidia and Kennel Cough, which is self-limiting and must run its course with antibiotic treatment and is not life threatening.If the puppy should die from a suspected genetic or birth defect within 12 months of its birth date, an autopsy must be performed at the purchaser's expense by a veterinarian. If the autopsy shows a congenital defect as the reason for death, the seller will provide another puppy of equal value to the purchaser of the buyer doesn't want a puppy we can refund half of the purchase price within 30 days and if the buyer wants a puppy later on with different parents we will offer a discount as well. A written statement from the licensed veterinarian must be provided with the Seller's name. The guarantee is void in the event of an indeterminable or inconclusive diagnosis. If an autopsy is not performed this guarantee is no longer valid and the puppy will not be replaced. Please understand once puppies leave me I have no clue what happened to them and proof needs to be given. This contract will only be valid while the seller is breeding Doodles. Should the Seller discontinue breeding dogs, this contract shall be void. This contract is between the Seller and Buyer(s) signed below. If this puppy/dog is sold to a third party, this contract shall be void.

Vaccinations Limitations: Your puppy has not been fully vaccinated and the recommended vaccination protocol schedule as age appropriate must be continued in order to maintain the one (1) year Guarantee outlined, the Buyer must have all immunizations done by a licensed veterinarian and provide proof of treatment to Seller upon request.

LIMITATION OF GUARANTEE: We do not guarantee fur color, eye color, adult size, conformation, reproductive ability, testicles descending, retained teeth, personality, potty training ability, proper bite, coat quality(shedding or no shedding, wavy, curly, wire, or flat coat), length, weight, physical flaws or the temperament of the puppy. Doodles are considered low shed and please be aware shedding is possible and to inform me of any allergies or health risk so I can place the best generation with your family. I am not responsible once puppies leave my possession I am not responsible for any puppies other then conditions under the health guarantee.

The Seller is not responsible for any veterinarian bills incurred once the puppy is delivered, the Buyer assumes all responsibility for the puppy. Buyer understands that adult sizes are an estimate only, based on Seller's experience.This guarantee does not cover any veterinarian costs associated with spaying or neutering, including undescended testes. We do not warrant against any condition caused by carelessness, negligence or abuse.

Limitation Provisions to Genetic Disease(s): Any puppy purchased from Danie's Darling Doodles must show a life threatening hereditary defect by 12 months of age. Dogs older than 12 months are not covered under this guarantee but is still under my discretion as I still want all my puppies to be healthy and happy. If after the Buyer discovers a life-threatening condition within a year of purchase and the owner wishes to retain the puppy the owner then waives the right to a replacement puppy unless otherwise agreed upon in writing from me.

Open Door Policy: If at any time, the Buyer can no longer retain possession of the dog, the Seller must be notified and granted full ownership of the dog back to Danie's Darling Doodles who will find a suitable home for the dog. If I do not have the space or you are out of town I will assist you with finding a new home buy posting or advertising the dog on my social media and sending all potential buyers directly to you. Our puppies are considered property of Danie's Darling Doodles . No refunds. The dog must be returned with all medical records. Under no circumstances will the Buyer rehome the dog, which includes surrendering the dog to the pound or any rescue center. This provision is to ensure that our dogs will not end up homeless or destroyed, and a proper suitable home is found. Rehoming of our puppy without written consent from me will be considered breach of contract.

Spay/Neuter Buyer's Responsibility: All Puppies purchased from Danies Darling Doodles are required to be spayed/neutered. If Buyer fails to Spay/Neuter their puppy and fails to provide proof to Seller by the time the puppy is 12 months of age, it will be considered a breach of contract. Health guarantee will also be voided. The buyer agrees to have this dog spayed/neutered by no later than 12 months from date of birth _____, and the buyer understands that this spay/neuter agreement is an agreement that this dog will not produce a litter of puppies either as purposely bred or by accidental breeding.. If for any reason, it is discovered the dog was used in any type of breeding Danie's Darling Doodles has the right to seek compensation in the amount of \$5000 (Breach of contract).

Legal Provisions: In the event of any litigation in connection with this contract, the Breeder will be paid reasonable attorney fees, court costs and all travel expenses, which resulted for the litigation via the responsibility of the Buyer. This Contract will be deemed a legally binding Contract, and is under the jurisdiction of the state of Michigan, in the county of Genesee. It is further agreed that, if for any reason, filing for court, the place of venue shall be Genesee County, Michigan.

Social media Clause We all love to share and post on social media and show off our new family members and that is perfectly fine. In the event you have an issue with your puppy or me DO NOT post a negative comment or review on any of my groups or pages instead reach out to me to settle the issue and I will do everything in my power to make it right. It can be a simple mistake or lack of communication on either part. Failure to communicate with me can ruin our reputation as well as our business relationships. So please do not post anything negative about my business that I have worked very hard to build over something that can easily be fixed. Slander and defamation of character can be morally and legally damaging. So please refrain from doing it and by signing this agreement you agree to the terms.

Bill of Sale: The Buyer of a puppy from Danie's Darling Doodles, hereby acknowledges that the Buyer has received a copy of this document, acknowledges and agrees to the terms and accepts full responsibility for the health and well-being of the purchased puppy. This is considered the complete "Bill of Sale". Further, the Buyer accepts the terms of the contract. The agreement represents the total agreement between Danie's Darling Doodles and the Buyer, and no other terms or conditions shall be valid to this sale.
